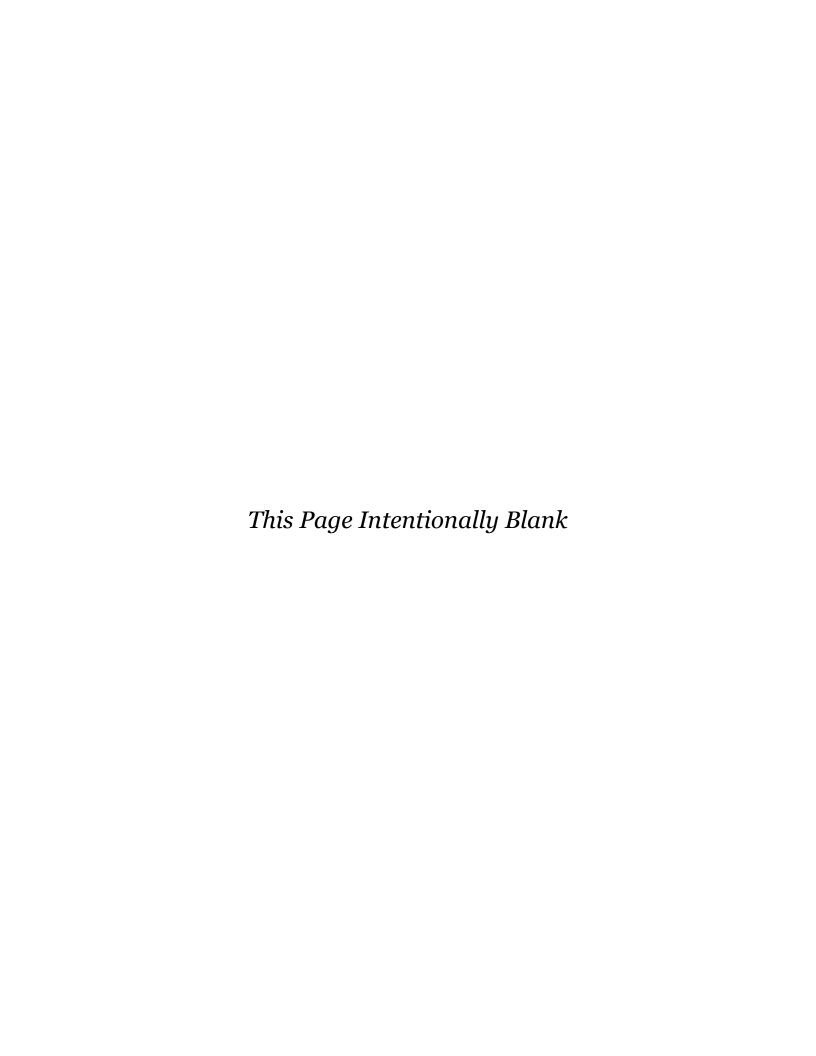

Dear Local Government Official,

Otter Tail Power Company and Missouri River Energy Services, on behalf of Western Minnesota Municipal Power Agency (collectively, the Applicants) plan to submit a Route Permit Application (RPA) to the Minnesota Public Utilities Commission (Commission) for the Minnesota portion of the Big Stone South to Alexandria 345 kilovolt (kV) high voltage transmission line (HVTL) and associated facilities that are proposed to be located in parts of Big Stone, Swift, Stevens, Pope, and Douglas Counties, Minnesota (the Project). The Project components include:

- Between 90 100 miles of a new double-circuit capable 345 kV transmission line between the Minnesota/South Dakota border and the existing Alexandria Substation;
- Double-circuit transmission structures consisting of steel, single-poles (monopoles); and
- Temporary laydown/staging areas, temporary pulling/tensioning sites, and temporary access roads for use during construction.

The Project comprises the Western Segment of the overall Big Stone South – Alexandria – Big Oaks 345 kV Transmission Project while the Eastern Segment stretches from Alexandria to Big Oaks near Becker, Minnesota, in Sherburne County. A Certificate of Need (CON) Application was filed with the Commission for the Minnesota portion of the overall Big Stone South – Alexandria – Big Oaks Project in September 2023 and assigned Docket No. E002, E017, ET2, E015, ET10/CN-22-538. A Route Permit Application was also filed with the Commission for the Eastern Segment on the same day and assigned Docket No. E002, E017, ET2, E015, ET10/TL-23-159. The Applicants are preparing to submit a RPA for the Project in the fourth quarter (Q4) of 2024.

A map of the proposed Project is attached to this letter as Figure 1.

This Project is part of a regional portfolio of new electric transmission projects identified by the Midcontinent Independent System Operator (MISO), the regional grid operator. This portfolio of new transmission projects will enhance reliability, reduce transmission congestion on the grid, increase resiliency during extreme weather events and increase access to low-cost energy.

This letter provides notice of the Project and the opportunity to arrange a preapplication consultation meeting with the Applicants in accordance with Minnesota Statutes § 216E.03, subds. 3a and 3b. Minnesota Statute § 216E.03, subd. 3b, provides local units of government the opportunity to request a consultation meeting regarding the proposed Project prior to the submission of the RPA to the Commission. If you are interested in meeting, please let us know by August 1, 2024.

As the Applicants have developed the Project, we held public open houses in April 2023, October 2023, February 2024, and June 2024 and attended numerous county and township meetings throughout the Project area to share information about the Project and gather input to assist us in developing the currently proposed routes for the Project. As such, the proposed route options shown in the attached Figure 1 are the result of considering extensive feedback and were developed based on: (1) comments received from landowners, community members, tribes, and other interested stakeholders; (2) information gathered from consultations with federal, state and local agencies; (3) applying required routing criteria from Minnesota laws; (4) analysis of publicly available data with a focus on minimizing impacts to landowners and the environment; (5) avoiding culturally significant sites and protected resources; and (6) maximizing co-location opportunities with other existing infrastructure. The Applicants are continuing to collect information to aid in refining the proposed routes that will be included in the upcoming RPA for the Project.

As noted above, this letter is being provided because the Applicants anticipate filing the RPA for the Project in the fourth quarter (Q4) of 2024. 
